

MEMBERSHIP AGREEMENT

ALL MEMBERSHIPS MAY BE USED TOWARD A MASSAGE, BASIC FACIAL, LASH LIFT, or RED LIGHT TREATMENT. All memberships must have a current credit card on file.

SIGNATURE: ONE HOUR MONTHLY

- Payment of \$88 will be drafted on the 5th 15th 25th day of the month.
- Payment of \$78 FAMILY will also be drafted on the same day.

SIGNATURE: ONE HOUR ANNUAL OR SEMI-ANNUAL

- Annual: Your payment at signing is \$1056 and you will receive 12 one-hour massage/facial sessions.
- Semi-annual: Your payment at signing is \$558 and you will receive 6 one-hour massage/facial sessions.

PREMIUM: ONE-AND-A-HALF HOUR MONTHLY

- Payment of \$118 will be drafted on the 5th 15th 25th day of the month.
- Payment of \$98 FAMILY will also be drafted on the same day.

PREMIUM: ONE-AND-A-HALF-HOUR ANNUAL OR SEMI-ANNUAL

- Annual: Your payment at signing is \$1416 and you will receive 12 one-and-a-half hour massage/facial sessions.
- Semi-annual: Your payment at signing is \$738 and you will receive 6 one-and-a-half hour massage/facial sessions.

Monthly Membership

Your membership includes one treatment listed above. Your membership allows you additional unlimited one-hour massages for \$68 each, one-and-a-half-hour massages for \$98 each. Membership is non-transferable. Your membership will automatically continue on a month-to-month basis at the current member rate. Massages and facials are accrued as individual sessions, not a dollar amount, and are valid to use as long as membership is current. Treatments cannot be split into 30-minute sessions.

Annual/Semi-Annual Membership

Memberships paid a year in advance include 12 (6) paid massage or facial treatments. Membership is non-transferable. Massages and facials are accrued as individual sessions, not a dollar amount. Treatments cannot be split into 30-minute sessions. Unused treatments expire 24 months from purchase date (Annual) or 12 months from purchase date (Semi-annual).

Membership Cancellation

Membership may be canceled at any time; allow **3 business days** to process. Please provide notice via **email to info@whitedahlia.com**. Yearly prepaid membership is non-refundable and non-transferable. Membership must be current to redeem unused massages. Initial _____

Appointment Cancellation Policy

24-hour notice is required for all cancellations. A **\$40 fee** will be assessed for failing to show for a scheduled appointment or not canceling an appointment outside the 24-hour cancellation window. **The full appointment price will be assessed if more than three late cancels or no-shows are accrued during a 12-month period.** Initial _____

Carry-Over Program

If massage or facial is not used within 30 days after purchase, it will be carried over to be used any time. Member treatments never expire as long as membership is current. A current credit card must be on file at all times to maintain membership. **Unused treatments are forfeited upon membership cancellation.** Initial _____

Sharing Services

Members may share services with others for a \$10 fee paid at the time of service. Member must give White Dahlia permission for another client to use their membership prior to service.
